NOTICE OF RACE

1 DATE, VENUE & ORGANISING AUTHORITY

- 1.1 The Paradise Point Sailing Club 2013 Summer Series will be held on the Broadwater from Sunday 20th Jan to Sunday 24th March 2013
- 1.2 The Host Club will be The Paradise Point Sailing Club

2 RULES

- 2.1 The regatta will be governed by the I.S.A.F Racing Rules of Sailing 2009-2012 (RRS), the rules of the relevant classes, except as any of these are altered by the sailing instructions.

3 ELIGIBILITY AND ENTRY

- 3.2 Eligible competitors shall be a member of an YA affiliated Yacht/Sailing Club
- 3.3 Any class rule that requires competitors to be members of the class association will not apply.
- 3.4 The regatta is open to all "off the beach" dinghy and catamaran classes.
- 3.5 Eligible boats may enter by completing the attached form and sending it to Paradise Point Sailing Club at PO Box 479 Paradise Point 4216 by Friday 18th Jan 2013. Entries will be accepted on the day however due to planning purposes the club would appreciate entries (with or without fee payment) by Friday 18th Jan 2013

4 FEES

12 RADIO COMMUNICATIONS

12.1 A boat shall neither make radio transmission while racing nor receive radio communication not available to all boats.

13 PRIZES

13.1 Prizes will be given out at the discretion of the Paradise Point Sailing Club.

14 DISCLAIMER OF LIABILITY

14.1 Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

15 INSURANCE

15.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of AUD \$5,000,000 per event or the equivalent.
